Sport England has stated that it is satisfied that the site of the proposed sport facilities will be equal in functional terms to the site being lost. The plans already submitted demonstrate that the grass pitch will accommodate under 16 football to the right spec. In addition the size of the AGP will also meet Mini soccer provision. This is also referenced back to us in your letter including meeting the specification.

Further, the FA have now confirmed that that the proposed AGP will be an improvement on the existing and are satisfied that the AGP will accord with the FA design guidance. Your objection was that the proposed AGP does not accord with the FA design guidance. The FA are happy that it does.

A condition attached to a planning consent to be agreed with the LPA prior to the commencement of work will state:-

Development of the artificial grass pitch shall not commence until full details of the design and layout of the artificial grass pitch, to be in accordance with current Sport England / FA Guidelines (including pitch layout / line markings, fencing, arrangements for storage of goals, proposed performance quality standard, and proposed surface type) have been submitted to and approved in writing by the Local Planning Authority. The artificial grass pitch shall be constructed in accordance with the approved details.

**The Council** now considers that the clarifications referenced in the letter dated 16th February 2016 have now been proved and there is no longer any grounds for Sport England to retain any objection to the proposal. I therefore kindly request that Sport England now withdraw its objection.
